

MADRID AGREEMENT AND PROTOCOL CONCERNING THE  
INTERNATIONAL REGISTRATION OF MARKS

**REQUEST FOR THE RECORDING OF A LICENSE**

(Rule 20*bis* of the Common Regulations)

**IMPORTANT**

1. This request may be presented to the International Bureau directly by the recorded holder or by the Office of the Contracting Party of the recorded holder or by the Office of a Contracting Party with respect to which the license is granted.
2. One single form may be used to request the recording of a license in respect of several international registrations of the same holder, **provided that**
  - the licensee is the same for **each** of the international registrations, and,
  - the license applies to all, or to the same, designated Contracting Parties for **each** of the international registrations, and,
  - the license concerns all, or the same, goods and services for **each** of the international registrations.
3. Where the request relates to several international registrations, a fee must be paid in respect of each international registration.
